Updates to FEMA's BRIC Program

FEMA has announced funding opportunities for the Building Resilient Infrastructure and Communities (BRIC) and Flood Mitigation Assistance (FMA) grant programs. This is the first round of funding for the BRIC program and \$700 million will be available.

These programs providing funding to states, tribes, territories, and local governments for mitigation activities that will strengthen our nation's recovery and resiliency before and after disasters. [FIND OUT MORE HERE](#)

Throughout the Western and Northwestern U.S., numerous states are battling massive fires due to extreme and prolonged dry weather, high/record high temperatures, and increased winds. With several members of the ISC team residing in the northern and central California areas, we have been receiving some firsthand updates on some of the recent blazes. The Dixie Fire in Plumas and Butte Counties has reached over 200,000 acres and has over 5,000 personnel working it. There have been homes and critical infrastructure lost, towns under mandatory evacuations, with other communities evacuated or under continued warnings. Communities have joined together, opening homes, land, and businesses to neighbors, as well as organizing donations to assist those who have had to leave or have lost their homes. Fire resources, including ground, air, and law enforcement from around the nation have arrived and continue to arrive to add continuous support and relief in this mountainous terrain of the country.

The ISC Team is standing by to assist in any capacity possible.


